### **Directions:**

For best results, allow this product to reach room temperature before using.

#### Rollers:

Remove wet ink. Apply small amount of Revitol across one of the distributor rollers and run in for 3 to 5 minutes. Keep rollers barely wet during run in. Advance washup blade and wash up in the usual manner with Wash V-120 or other Varn water miscible wash to remove imbedded pigment and glaze.

#### Blankets:

Wipe blanket with Revitol. Allow to penetrate, then wash up before the press is run. To restore a velvet feel, leave Revitol on blankets overnight or over a weekend, then wash up thoroughly with a good water miscible press wash.
